

# Sense of Place

## Rules

These terms and conditions govern the CPRE Shropshire photo awards 2025.

The organiser is CPRE Shropshire. By accepting these Terms & Conditions and subsequently submitting your photographs, you have entered into an agreement with the organiser. The organiser reserve the right to modify these terms and conditions without notice.

- 1) **The awards close for entries on Sunday 31st August 2025.** Entries submitted after this date will not be accepted.
- 2) Photos must be taken within the boundaries of the country of Shropshire, including Telford & Wrekin.
- 3) Image files are required in jpeg format only. If your image is selected we will need a copy of the file at high resolution (300dpi ideally) to print it. Images may be taken with smartphones/iPads.
- 4) Entrants must submit a completed Entry Form with their image/s.
- 5) All images \*\*must\*\* be titled/labelled with the entrant's name and entry number (eg *John Smith, entry1*) to correspond with the Entry Form.
- 6) Images should be submitted to <a href="mailto:photos.cpreshropshire@gmail.com">photos.cpreshropshire@gmail.com</a> Alternatively entrants may use <a href="mailto:We Transfer">We Transfer</a> to supply image files.
- 7) All entries must be their own work and signing the entrant form confirms that you own the copyright for your submissions. Do not infringe the copyright of any third party or any laws. Copyright for all images submitted for this competition remains with the respective entrants\*.
- 8) CPRE Shropshire may feature any or all of the submitted images in any of their publications, social media, websites and/or in any promotional material connected to these awards.

#### Eligibility

- 9) Sense of Place is open to residents of the UK, but photographs **must be** of the Shropshire county (including the borough of Telford & Wrekin).
- 10) The awards are open to anyone of any age with the following exceptions: a) individuals directly involved in organising or selecting the works, b) individuals that work for CPRE Shropshire.
- 11) If you are under the age of 18 you must have permission to enter from your parent or guardian. By submitting an entry for the competition, your parent or guardian is deemed to have given such consent and to agree to the use of the entry as described in these terms and conditions.

#### **Image Selection**

- 12) Those selected for the exhibition will be notified by Monday 30th September by email at the latest.
- 13) The selection panel will include members of the CPRE management team and the Gateway Gallery (Shrewsbury). Their selection decisions are final.
- 14) Entries will be assessed against the brief and title 'Sense of Place'. The judges will select images based upon meeting the assignment requirements, technical skill, originality and creativity.
- 15) You agree that if you are a winner/runner up you will attend the preview (in October 2025 at the Gateway Gallery) and to the use of your name in all publicity and promotion.
- 16) By submitting photos you are accepting these rules.

#### **Awards**

- 17) All selected entries will be professionally printed by Frame it, Shrewsbury
- 18) All selected entries will be exhibited at the Gateway Gallery, Shrewsbury, Shropshire in October 2025 and potentially shown in follow-up exhibitions
- 19) An award of £150 will be given to the entry deemed to be the one that best meets the entry requirements. The award will be by a cheque.
